

Fellow of IACLE (FIACLE) AGREEMENT & APPLICATION

Entry level FIACLE criteria

IACLE's <u>Board of Directors</u> approves an IACLE member to become a Fellow of IACLE (FIACLE) when they meet the following criteria:

- Successfully completed the IACLE Fellowship Exam, and
- Has held membership for at least one year or more, and
- Continues to qualify as a member, and
- Is a financial member (fees are paid up to date), and
- Promotes IACLE educational goals and objectives, and
- Continues to contribute to contact lens education, and
- Participates in programs that advance contact lens education

Maintaining FIACLE status

As a Fellow, you will follow IACLE Member guidelines and FIACLE guidelines, plus each year IACLE expects that you are engaged in at least three of the activities below:

- Developed and presented at least one lecture or workshop session to practitioners, and/or educators
- Submitted and/or published a journal article or book chapter in an international journal or textbook
- Participated and/or attended relevant conferences for your personal continued professional development
- Presented at an IACLE Meeting or an IACLE Webinar
- Developed and donated an educational resource to IACLE
- · Actively involved in research activity related to contact lenses

FIACLE Terms & Conditions:

- 1. A Member who wishes to become a Fellow of the Association shall submit to the IACLE Secretariat/local IACLE office a FIACLE Application for Fellow of IACLE (FIACLE).
 - All applications shall be reviewed by the IACLE Regional/National Coordinator, who shall make a recommendation concerning the application to the Board of Directors for approval.
- 2. The Board of Directors shall not admit to Fellow status any member who in the opinion of the Board does not meet all the conditions for Fellow status. In the event of the Board of Directors declining to admit a member to Fellow status, the Board of Directors shall not be bound to give any reason for its refusal.
- 3. Fellows shall be issued with a certificate stating, 'Fellow of IACLE' and shall be entitled to use the designation 'FIACLE' on letterhead, business cards and email signatures, providing that the Fellow is a recognized and current Fellow and a current IACLE member in good standing.
- 4. Any Fellow who is found to have made a false declaration shall immediately forfeit the rights and privileges of Fellow status and the use of the title 'FIACLE'.
- 5. The IACLE Regional/National Coordinator may recommend revocation of Fellow status to the Board of Directors of any member who is found not to meet the conditions of Fellow status.

- 6. Whenever a meeting of the Board of Directors is called to approve revocation of a Fellow status, the Fellow concerned shall be notified of the intention of the Board to act. Such a person shall be given the opportunity to make a written submission to the Board.
- 7. A decision against an applicant for Fellow of IACLE status may be appealed to a special subcommittee (the Appeals Subcommittee) set up for that purpose.
- 8. On receipt of such a request the Secretariat shall call a meeting of the Appeals Subcommittee which shall consider the written submission of the member who has been denied Fellow status and shall decide by secret ballot conducted at the meeting whether the member shall be interviewed, admitted, or restored to Fellow status and such decision shall be binding and conclusive and without any further appeal.
- 9. Members who have achieved Fellow of IACLE (FIACLE) status but whose membership has expired for three years or more, lose their FIACLE status. FIACLE status cannot be renewed just by renewing IACLE membership, nor can the member use the suffix FIACLE. The member is required to successfully complete the Fellowship Exam again and on approval can become a Fellow again.
- 10. A Fellow in good standing who has completed 15 years as a Fellow is eligible by invitation from IACLE as a Lifetime FIACLE if they remain an active member and meet the terms and conditions of FIACLE.
- 11. A Fellow in good standing who has completed 15 years as a Fellow and has retired and been awarded Honorary Member status may continue to be a Fellow and exercise all the rights and privileges of Fellow status without the need for continued membership status or review.
- 12. When renewing membership and paying annual dues, the Fellow must declare that they continue to adhere to the terms and conditions of Fellow status. Submission of resource(s) produced by the Fellow is encouraged for contribution towards the IACLE Library accessed via IACLETOP. Resources are to be submitted to IACLE along with a short biography and list of affiliates.
